PH 255A Introduction to Social Epidemiology

University of California, Berkeley, School of Public Health

Description: This course introduces students to the field of social epidemiology and its role in understanding the social determinants of population health and health disparities. This course will provide a systematic and selected overview of literature in the field covering the history and development of the field of social epidemiology, theoretical perspectives, major topical areas, conceptual approaches, and current controversies related to theory, research methods, and research findings.
